Residents who wish to vote in the City of Dover special municipal election must be:

- A Resident of the City of Dover First (1st) District
- Eighteen (18) Years of Age or Older by the Time of the Election
- Registered to Vote with the State of Delaware Department of Elections by Saturday, November 6, 2021.**
(In accordance with Delaware Code - Title 15 and the City's Charter - Section 8)

Any qualified elector, duly registered, may cast their vote by **ABSENTEE BALLOT** if they are unable to go to their regular polling place during the forthcoming election for any of the following reasons:

- In the public service of the U.S. or of this State, or a citizen of the U.S. temporarily residing outside the territorial limits of the U.S. and the District of Columbia, or such person's spouse or dependent when residing with or accompanying the person, or absent from this State because of illness or injury received while serving in the armed forces of the U.S.; or
- In the armed forces of the U.S. or the Merchant Marines of the U.S., or attached to and serving with the armed forces of the U.S. in the American Red Cross or United Service Organizations; or
- Because of the nature of such person's business or occupation (This includes persons providing care to a parent, spouse or child who is living at home and requires constant care; students; and otherwise eligible persons who are incarcerated); or
- Sick or physically disabled; or
- Absent from the municipality while on vacation; or
- Unable to vote at a certain time or on a certain day due to the tenets or teachings of that person's religion.
